## Intended Purpose

Hāpai Atū (formerly Quick CLIC) is best for patients who have a well-managed LTC (long term condition) usually, but are experiencing a short term exacerbation, or an acute episode of another health problem. These patients are expected to return to their usual level of wellness, after a short period of increased support and intervention from their practice team. E.g. patient is usually well managed with an LTC but has had a recent new event such as a MI (myocardial infarction), or is having an acute mental health exacerbation.

## Eligibility

- Patient must have a long term condition

## Exclusion

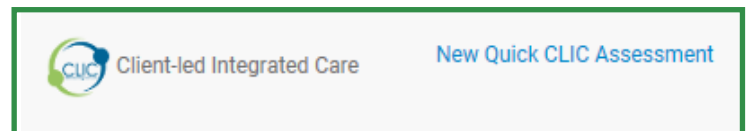
- Patients who have been on Hāpai Atū in the last 12 months.

## Key Information

- Complete Hāpai Atū in the WellSouth portal. You are required to document what the patient's main presenting issue is and what interventions the practice team will implement to support the patient. This support is to occur over a period of no more than 6 months. You MUST complete one care plan. This can be either a Personalised Care Plan (PCP) or an Acute Plan. This must be uploaded in HealthOne.
- See [Health Pathways](#) for further information on the care plans, and tips for how to complete them.
- Complete a review for the patient anytime within the ensuing 6 months. This review is there to identify what interventions and outcomes have occurred for the patient. Review can take place at any time from a few weeks after initial assessment, through to the full 6 months.
- Patient can be registered on both Toitū Takata and Hāpai Atū, however these will require PHO review before payment. Cannot claim both on the same day.

## Claiming

Claiming is via the WellSouth PHN portal.

## Can a co-payment be charged?

No co-payment can be charged.

## When does the claim need to be completed?

Hāpai Atū assessment should be claimed within 2-months of initial registration.

Review and exit must be claimed within 2-months of eligible exit date.

Claims may be subject to Audit at WellSouth discretion.
